Do you offer group discounts?

Group discounts and bundled packages are not available.

Is accommodation included in the conference ticket?

Accommodation is not included and must be arranged directly by each participant.

If you prefer to stay in the city, we recommend choosing accommodation in Brussels city centre or the European Quarter. Both areas offer direct, reliable connections to Brussels Airport by train or bus.

How do I know if my registration was successful?

All registrations must be completed through Eventbrite. Upon registering, you will receive an automatic confirmation email and an Eventbrite receipt. Your registration is successful only once: full payment has been received (via Eventbrite or bank transfer if invoicing was selected), ECCA has verified the participant's professional affiliation and you receive a confirmation email. Please check your spam or junk folder if you do not see the confirmation email.

If a registration is rejected, the organisers will contact the affected participant directly.

Has my payment been processed?

Your payment has been processed if you receive a confirmation email along with an Eventbrite receipt confirming payment. Be sure to check your spam or junk folder if it doesn't appear in your inbox.

If you have not received a confirmation email or receipt, your payment may not have been processed. Please verify whether any payment has been deducted from your bank account or card. If your registration is unsuccessful, please try the following steps:

1. Verify all card and billing details are entered correctly.
2. Clear your browser's cache and cookies or try registering with a different browser or device.
3. Disable any VPN and ensure you are logged in before retrying your payment.
4. Try another credit/debit card or contact your bank to ensure the payment isn't being blocked.

Can I cancel my registration?

Cancellations made by September 7 at 13h00 CEST will incur a 100 EUR management fee plus the Eventbrite platform fee. Later than this, no refunds will be issued. Written notice must be sent to ecca.conference@ecco-eu.com.

Can I transfer my ticket to a different participant?

If a registered participant is unable to attend, a substitute may be nominated by September 7 at 13h00 CEST. Written notice must be sent to ecca.conference@ecco-eu.com. A 50 EUR processing fee (excluding VAT) applies, and payment will be handled through the Eventbrite platform. Please note that if the new participant falls under a higher-priced registration category, the price difference must be paid before the name change is finalised.

Why is Belgian VAT applicable?

Physical events in the EU are taxed in the country where they take place. Because this conference is held in Belgium, the standard 21% Belgian VAT applies to all registrations, regardless of the participant's or organiser's location.

For further information about VAT, including whether your organisation is eligible to reclaim Belgian VAT, please consult your accountant or tax advisor.

Can I attend online?

The conference is fully in-person and does not offer remote participation.

Can I join only one conference day?

Yes, you may attend only one day; however, please note that all tickets grant access to both days, and single-day tickets are not offered.
